Kommentar

This course serves as an introduction to the linguistic description and analysis of language on the level of discourse. While building on the knowledge acquired in the introductory module, we will move beyond the analysis of single, isolated and de-contextualised sentences. We will investigate how participants use language as a resource for communicating and interacting with each other, for structuring and unifying discourse and for displaying social identity, beliefs and opinions. Furthermore, we will discuss the role of context and co-text for (fully) understanding any (written) text or (spoken) piece of discourse.

To achieve the following/the learning outcome (see below), students will be expected to prepare a selection of weekly readings as well as worksheets (see course schedule below) . In the sessions, we will discuss central concepts from the material, but our focus will be on applying the theory. Regular hands-on analyses of genuine (written and spoken) English data will serve as preparation for the assessment.

LEARNING OUTCOME

After attending this class, participants are expected to be able to independently analyse a piece of discourse according to the models and concepts discussed in class by

- identifying and describing its context and co-text;
- discussing the piece of discourse against the background of its manner of production and mode of representation, as well as its location on the orality-literacy scale;
- investigating language use as a resource to (re)construct speaker identities and ideologies;
- analysing the piece of discourse using the frameworks of both Speech Act Theory and Conversation Analysis;
- discussing utterances against the background of pragmatic principles;
- describing cohesive and thematic patterns underlying texture;
- and
- basing their analysis on, and referencing, a solid theoretical foundation;

as well as

- presenting their findings in a suitable (oral and written) manner so that they later can access these skills, both in advanced classes concerned with the subject matter and in their working environment.

The course allows you to obtain three credit points (LP). Please note that this corresponds to 75-90 hours of work. Your workload for this class will encompass

- preparation of the course material, by yourself or in your team;
- regular and active participation in class, and taking part in team activities and hands-on analyses*;

- submitting an individual short written version of your sample analysis (1000-1500 words).

Kommentar

The ancient world had very high rates of human mobility and moments when 'the foreigner in our midst' was not a problem, while other periods are characterised by what on the surface appears to be xenophobia, yet even then movement continued both voluntary or forced, whether for trade, piracy, wars, festivals, escape or love interests. One of the problems of the ancient world was how to keep one's own people in one place. The course will incorporate human mobility trends and the attitudes to them across a wide chronological and geographic spectrum. As its core case study it will use the ancient world centred on the Mediterranean, especially Italy before Empire, but it anticipates students from multiple disciplinary backgrounds who will be able to apply the concepts and problems discussed to their own time period and disciplinary interest. It will include approaches to the subject of mobility and the changing concepts of borders, place, citizenship and the foreigner. These issues will inform our understanding of how communities construct and use place and space, in relation to memory, identity and power. This course brings together a dynamic group of students to discuss urgent issues of our time through intriguing ancient sources and current select readings (not all those listed in each session). It will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will have the possibility to join a Global Studies trip to Friedland Museum (near Göttingen). Students will get extra credit attending as audience an International Global LAB student virtual conference at Princeton. Encounters between hosts and strangers are at the core of some of our oldest surviving narratives through time. The actions and decisions taken over the threshold, whether in welcome or repulsion, serve to position society within a moral framework, and simultaneously re/define the framework itself. Asylum appeals, by their nature, constitute the 'host' through pointing to the existence of bodies positioned external to it. Yet, the negotiations for refuge also expose the ambiguity of who the host is. In this course we will seek to understand how value is drawn from persons, whose condition is reduced to being bodies out of place. That is whose physical position means removal from – a place of rights, protection and belonging – whether through expulsion or by being relegated to spaces of constrained mobility – asylum seekers, refugees, exiles, captives and those without effective citizenship. We will draw on ancient and modern and imaginary liminal settings to investigate the unique role of people in such states for articulating intra-community relations and the space between civil rights and human rights. Individuals and groups in such positions of liminality – whose state is considered one of exception and characterised by precarity, unsettledness and threat of violence have a significant role in articulating the parameters of the non-exceptional – the so called 'norm'. Here the perplexities of sovereignty are revealed, not only for the host, but for those – citizen-strangers, the stateless or people with non-effective citizenship – whose existence lies seemingly beyond the possibilities of sovereign action, and yet there is the power to invoke it. The course brings together a dynamic group of students and international experts to discuss urgent issues of our time. Aside from discussions about select readings (not all those listed in each session), it will include 'meet the author' sessions (and possibly a joint effort to coordinate hosting the guest), a trip to Friedland Museum Transit Camp, and will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will get extra credit by attending as audience members an International Global LAB student virtual conference at Princeton. Kommentar

As we witness multiple ways people are on the move, by desire or by force, crisscrossing oceans, mountains, skies and at times borders, we note that the unceasing movement may be accompanied by a surge of assertions about fixity of people, importance of sustaining traditions and the naturalness of ethnic or national boundaries. These are often projected back into history as the norm. As movement increases, voices proclaim desirability of the opposite – and with it emerge stories of pause and homelands – real and imagined. It could be that we are faced with just such a moment now in the 21st century. An emphasis on locality and homeland, while living in an age of intense mobility, is not an uncommon paradox. It does not disprove the mobility thesis, and may even confirm it – we cannot get away from the immense impact of movement in our evidence. Yet, it is a response that gives prominence to stasis rather than motion as the basis for understanding transformations of human relations with each other and the natural world around us. This view has affected how we interpret societal forms, the creation of institutions, formation of boundaries and modes of cultural interaction and belonging. If, however, we accept the fact of a mobile rather than a stable society, our understanding of the dynamics of change alters. Migration becomes a constitutive presence and not a challenge to an otherwise naturally static state. The historical paradigms we will explore in this lecture series with international guests and ROUTES network (Exeter, UK), touch on different moments in time, providing a long-term perspective on contemporary concerns by locating them in rival contexts. In these dynamic situations human mobility is sometimes thought acceptable, and sometimes perceived as anathema, and the person coming from elsewhere may be welcomed or repelled simply for being from elsewhere.

Bemerkung							
Many refer to our current times as the age of the Anthropocene, marked by the devastating effects of anthropogenic (human-made) destruction, of which polluted oceans, deforestation, mass extinction and climate-induced displacement are only a few examples. At the same time, such an approach that focuses on humans as a global, geological force runs the danger of homogenizing 'the human' in ways that obscures how both harms and responsibilities are unequally distributed: after all, not all humans in all parts of the world are implicated in and affected by climate collapse and environmental destruction in the same ways. How do we live in this contemporary moment differently and across differences, sharing certain experiences such as 'sostalgia' or 'climate angst,' while yet facing different risks and harms in our lives, and having different forms of agency available? Environmental catastrophes, furthermore, affect not only humans but also the more-than-human world, thus begging the question of multispecies forms of justice. It is through literature that we will interrogate how the effects of environmental crises are unevenly distributed along lines of race, gender, class, and citizenship, as well as across different species, and how these play out against the background of North American environmental and immigration politics as well as ongoing (settler) colonialism. We will trace how literary works engage in different ways with questions of justice: how do they portray interconnected forms of environmental injustice, both social and ecological injustice? How do they imagine forms of justice? Students should be willing to engage with different text forms and genres, including prose, (video-) poetry and theory. They should be ready to approach the texts with curiosity and open-mindedness, to challenge and rethink their own assumptions, and to engage with each other in a shared process of learning. Format : This class alternates between in-person (synchronous/live) classes on campus and online (asynchronous/at home) sessions on a biweekly basis . It therefore requires both in-class attendance and online participation. In order to allow for more in-depth discussions in class, and to hone in on their critical reading and writing skills, students are expected to work independently with materials provided for them in the asynchronous sessions.

Kommentar

This course will provide a space for critical interrogation and discussion of food cultures and the politics that are associated with them. We will tackle questions of conspicuous consumption, the coloniality of food habits as well as ideologies associated with the human body. The foundational tenet of this seminar is that food is of particular political relevance despite attempts to portray it as 'just culture'.

Literatur

Prospective participants should also start looking critically at the food cultures and material consumption with which they engage every day as class, race and gender structure food practices. Part of this critical self-reflection will be the creation of a food protocol over two weeks in order to help students identify aspects of their food ways that they find particularly interesting.

All students will take part in short online feedback exercises throughout the semester.

For **3 ECTS ungraded**, participants will facilitate in-class discussion on a given day by introducing relevant resources as well as critical questions and moderating the debate.

Kommentar

Throughout the Victorian Era, the ghost story has often served as a means to address unconformable topics such as death, sexuality and fears of degeneration more directly than could have been done in more realistic fiction. Women writers used the genre to criticise their gender role restrictions in the patriarchal society which saw marriage and motherhood as the only proper occupations for women. Similarly, authors used the form to write about men and the gender expectations they were supposed to act on. By leaving a loophole for a rational explanation of the seemingly supernatural events, these stories hinted at the possibility that ghosts are nothing but a hallucination and are therefore not located in external forces but within the mind of the ghost-seer. Thus, the genre provided a platform for the subtle criticism of societal issues.

In this seminar, we will explore the characteristics of the ghost story and examine the ways in which the genre was used to erode, challenge, mock and/or blur contemporary ideas about gender, sexuality, and the supposed superiority of the white Englishman. For this purpose, we will read a wide selection of stories – among them stories by famous authors such as Charles Dickens, Rudyard Kipling and Arthur Conan Doyle. In the course of the semester, we will also discuss literary theories about ghost stories and encounter Sigmund Freud and his psychological concept of the uncanny.

Kommentar

In his book *Phonographies: Grooves in Sonic Afro-Modernity*, Alexander Weheliye argues for the importance of sound reproduction technologies in the creation of a "sonic Afro-Modernity". Weheliye critiques Modernity's focus on ocularcentrism and proposes instead to attune to an aural mode of being and becoming, a "sound thinking", which he sees emerging in black and Afro-diasporic literary and musical engagement with sound technologies. By way of Weheliye's notion of phonography (literally: sound-writing), we want to think about issues of writing, reproduction and performance (as well as their entanglements). Phonographic re/production blurs the dichotomy of object and subject, as Fred Moten, Theodor W. Adorno and other theorists have argued. In this seminar, we want to read Weheliye's book to investigate theories of phonography which can function as a different entry point into studying cultural and aesthetic productions (texts, sounds, music, etc.). We will primarily read Weheliye's monograph, with the addition of some shorter texts to provide responses and context. In class, students will have to prepare short response papers and there will be plenty of space to listen to examples that illustrate or probe the theory.

This class will be taught by Malte Kobel.

Kommentar

The ancient world had very high rates of human mobility and moments when 'the foreigner in our midst' was not a problem, while other periods are characterised by what on the surface appears to be xenophobia, yet even then movement continued both voluntary or forced, whether for trade, piracy, wars, festivals, escape or love interests. One of the problems of the ancient world was how to keep one's own people in one place. The course will incorporate human mobility trends and the attitudes to them across a wide chronological and geographic spectrum. As its core case study it will use the ancient world centred on the Mediterranean, especially Italy before Empire, but it anticipates students from multiple disciplinary backgrounds who will be able to apply the concepts and problems discussed to their own time period and disciplinary interest. It will include approaches to the subject of mobility and the changing concepts of borders, place, citizenship and the foreigner. These issues will inform our understanding of how communities construct and use place and space, in relation to memory, identity and power. This course brings together a dynamic group of students to discuss urgent issues of our time through intriguing ancient sources and current select readings (not all those listed in each session). It will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will have the possibility to join a Global Studies trip to Friedland Museum (near Göttingen). From a poem by Jazra Khalid, Gayath Said: ##### the War is Coming

Encounters between hosts and strangers are at the core of some of our oldest surviving narratives through time. The actions and decisions taken over the threshold, whether in welcome or repulsion, serve to position society within a moral framework, and simultaneously re/define the framework itself. Asylum appeals, by their nature, constitute the 'host' through pointing to the existence of bodies positioned external to it. Yet, the negotiations for refuge also expose the ambiguity of who the host is. In this course we will seek to understand how value is drawn from persons, whose condition is reduced to being bodies out of place. That is whose physical position means removal from – a place of rights, protection and belonging – whether through expulsion or by being relegated to spaces of constrained mobility – asylum seekers, refugees, exiles, captives and those without effective citizenship. We will draw on ancient and modern and imaginary liminal settings to investigate the unique role of people in such states for articulating intra-community relations and the space between civil rights and human rights. Individuals and groups in such positions of liminality – whose state is considered one of exception and characterised by precarity, unsettledness and threat of violence have a significant role in articulating the parameters of the non-exceptional – the so called 'norm'. Here the perplexities of sovereignty are revealed, not only for the host, but for those – citizen-strangers, the stateless or people with non-effective citizenship – whose existence lies seemingly beyond the possibilities of sovereign action, and yet there is the power to invoke it. The course brings together a dynamic group of students and international experts to discuss urgent issues of our time. Aside from discussions about select readings (not all those listed in each session), it will include 'meet the author' sessions (and possibly a joint effort to coordinate hosting the guest), a trip to Friedland Museum Transit Camp, and will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will get extra credit by attending as audience members an International Global LAB student virtual conference at Princeton. Kommentar

As we witness multiple ways people are on the move, by desire or by force, crisscrossing oceans, mountains, skies and at times borders, we note that the unceasing movement may be accompanied by a surge of assertions about fixity of people, importance of sustaining traditions and the naturalness of ethnic or national boundaries. These are often projected back into history as the norm. As movement increases, voices proclaim desirability of the opposite – and with it emerge stories of pause and homelands – real and imagined. It could be that we are faced with just such a moment now in the 21st century. An emphasis on locality and homeland, while living in an age of intense mobility, is not an uncommon paradox. It does not disprove the mobility thesis, and may even confirm it – we cannot get away from the immense impact of movement in our evidence. Yet, it is a response that gives prominence to stasis rather than motion as the basis for understanding transformations of human relations with each other and the natural world around us. This view has affected how we interpret societal forms, the creation of institutions, formation of boundaries and modes of cultural interaction and belonging. If, however, we accept the fact of a mobile rather than a stable society, our understanding of the dynamics of change alters. Migration becomes a constitutive presence and not a challenge to an otherwise naturally static state. The historical paradigms we will explore in this lecture series with international guests and ROUTES network (Exeter, UK), touch on different moments in time, providing a long-term perspective on contemporary concerns by locating them in rival contexts. In these dynamic situations human mobility is sometimes thought acceptable, and sometimes perceived as anathema, and the person coming from elsewhere may be welcomed or repelled simply for being from elsewhere.

In 1984, Gayle Rubin wrote that "it is precisely at times such as these, when we live with the possibility of unthinkable destruction, that people are likely to become dangerously crazy about sexuality." Rubin shows that while for some sexuality may seem an unimportant topic, "a frivolous diversion from the more critical problems of poverty, war, disease, racism, famine, or nuclear annihilation," the abjection of sexual behaviors, discourses, and subjectivities deemed abnormal and unhealthy is more than collateral for political projects. Kommentar

This course introduces students to the field of Australian Studies through a focus on different Australian places. It asks how these places are often simultaneously understood and imagined as Indigenous Country, as the site of colonisation and settler homemaking, or as locations of a modern multicultural nation. The process of narration plays an important role in such understandings and imaginings of places and we will focus on how and why such narratives (in the broadest sense) are constructed and what forms they might take. Starting out from an engagement with the Aboriginal Australian concept of 'Country', we will focus on iconic Australian locations such as the outback, the beach, the city, or the border and ask how they are narrated across a range of cultural productions including literature, film and the visual arts.

The course is part of the EDUC alliance and has been developed collaboratively between Masaryk University, Czech Republic, and the University of Potsdam, Germany. To allow for close collaboration between lecturers and students from both universities, the course will be partially co-taught. Students must generally be able to attend all classes listed in the schedule.

Next to the regular class time, this course is also taught in 5 joint online sessions with our Czech partners on 21 April, 28 April, 5 May, 12 May and 19 May from 10:15-11:45 am.

This course introduces students to the field of Australian Studies through a focus on different Australian places. Bemerkung

Many refer to our current times as the age of the Anthropocene, marked by the devastating effects of anthropogenic (human-made) destruction, of which polluted oceans, deforestation, mass extinction and climate-induced displacement are only a few examples. At the same time, such an approach that focuses on humans as a global, geological force runs the danger of homogenizing 'the human' in ways that obscures how both harms and responsibilities are unequally distributed: after all, not all humans in all parts of the world are implicated in and affected by climate collapse and environmental destruction in the same ways. How do we live in this contemporary moment differently and across differences, sharing certain experiences such as 'sostalgia' or 'climate angst,' while yet facing different risks and harms in our lives, and having different forms of agency available? Environmental catastrophes, furthermore, affect not only humans but also the more-than-human world, thus begging the question of multispecies forms of justice. It is through literature that we will interrogate how the effects of environmental crises are unevenly distributed along lines of race, gender, class, and citizenship, as well as across different species, and how these play out against the background of North American environmental and immigration politics as well as ongoing (settler) colonialism. We will trace how literary works engage in different ways with questions of justice: how do they portray interconnected forms of environmental injustice, both social and ecological injustice? How do they imagine forms of justice?

Students should be willing to engage with different text forms and genres, including prose, (video-) poetry and theory. They should be ready to approach the texts with curiosity and open-mindedness, to challenge and rethink their own assumptions, and to engage with each other in a shared process of learning.

Format : This class alternates between in-person (synchronous/live) classes on campus and online (asynchronous/at home) sessions on a biweekly basis . It therefore requires both in-class attendance and online participation. In order to allow for more in-depth discussions in class, and to hone in on their critical reading and writing skills, students are expected to work independently with materials provided for them in the asynchronous sessions.

Kommentar

In his book *Phonographies: Grooves in Sonic Afro-Modernity*, Alexander Weheliye argues for the importance of sound reproduction technologies in the creation of a "sonic Afro-Modernity". Weheliye critiques Modernity's focus on ocularcentrism and proposes instead to attune to an aural mode of being and becoming, a "sound thinking", which he sees emerging in black and Afro-diasporic literary and musical engagement with sound technologies. By way of Weheliye's notion of phonography (literally: sound-writing), we want to think about issues of writing, reproduction and performance (as well as their entanglements). Phonographic re/production blurs the dichotomy of object and subject, as Fred Moten, Theodor W. Adorno and other theorists have argued. In this seminar, we want to read Weheliye's book to investigate theories of phonography which can function as a different entry point into studying cultural and aesthetic productions (texts, sounds, music, etc.). Kommentar

The ancient world had very high rates of human mobility and moments when 'the foreigner in our midst' was not a problem, while other periods are characterised by what on the surface appears to be xenophobia, yet even then movement continued both voluntary or forced, whether for trade, piracy, wars, festivals, escape or love interests. One of the problems of the ancient world was how to keep one's own people in one place. The course will incorporate human mobility trends and the attitudes to them across a wide chronological and geographic spectrum. As its core case study it will use the ancient world centred on the Mediterranean, especially Italy before Empire, but it anticipates students from multiple disciplinary backgrounds who will be able to apply the concepts and problems discussed to their own time period and disciplinary interest. It will include approaches to the subject of mobility and the changing concepts of borders, place, citizenship and the foreigner. These issues will inform our understanding of how communities construct and use place and space, in relation to memory, identity and power. This course brings together a dynamic group of students to discuss urgent issues of our time through intriguing ancient sources and current select readings (not all those listed in each session). It will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will have the possibility to join a Global Studies trip to Friedland Museum (near Göttingen). Students will get extra credit attending as audience an International Global LAB student virtual conference at Princeton. Encounters between hosts and strangers are at the core of some of our oldest surviving narratives through time. The actions and decisions taken over the threshold, whether in welcome or repulsion, serve to position society within a moral framework, and simultaneously re/define the framework itself. Asylum appeals, by their nature, constitute the 'host' through pointing to the existence of bodies positioned external to it. Yet, the negotiations for refuge also expose the ambiguity of who the host is. In this course we will seek to understand how value is drawn from persons, whose condition is reduced to being bodies out of place. That is whose physical position means removal from – a place of rights, protection and belonging – whether through expulsion or by being relegated to spaces of constrained mobility – asylum seekers, refugees, exiles, captives and those without effective citizenship. We will draw on ancient and modern and imaginary liminal settings to investigate the unique role of people in such states for articulating intra-community relations and the space between civil rights and human rights. Individuals and groups in such positions of liminality – whose state is considered one of exception and characterised by precarity, unsettledness and threat of violence have a significant role in articulating the parameters of the non-exceptional – the so called 'norm'. Here the perplexities of sovereignty are revealed, not only for the host, but for those – citizen-strangers, the stateless or people with non-effective citizenship – whose existence lies seemingly beyond the possibilities of sovereign action, and yet there is the power to invoke it. The course brings together a dynamic group of students and international experts to discuss urgent issues of our time. Aside from discussions about select readings (not all those listed in each session), it will include 'meet the author' sessions (and possibly a joint effort to coordinate hosting the guest), a trip to Friedland Museum Transit Camp, and will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will get extra credit by attending as audience members an International Global LAB student virtual conference at Princeton. Kommentar

As we witness multiple ways people are on the move, by desire or by force, crisscrossing oceans, mountains, skies and at times borders, we note that the unceasing movement may be accompanied by a surge of assertions about fixity of people, importance of sustaining traditions and the naturalness of ethnic or national boundaries. These are often projected back into history as the norm. As movement increases, voices proclaim desirability of the opposite – and with it emerge stories of pause and homelands – real and imagined. It could be that we are faced with just such a moment now in the 21st century. An emphasis on locality and homeland, while living in an age of intense mobility, is not an uncommon paradox. It does not disprove the mobility thesis, and may even confirm it – we cannot get away from the immense impact of movement in our evidence. Yet, it is a response that gives prominence to stasis rather than motion as the basis for understanding transformations of human relations with each other and the natural world around us. This view has affected how we interpret societal forms, the creation of institutions, formation of boundaries and modes of cultural interaction and belonging. If, however, we accept the fact of a mobile rather than a stable society, our understanding of the dynamics of change alters. Migration becomes a constitutive presence and not a challenge to an otherwise naturally static state. The historical paradigms we will explore in this lecture series with international guests and ROUTES network (Exeter, UK), touch on different moments in time, providing a long-term perspective on contemporary concerns by locating them in rival contexts. In these dynamic situations human mobility is sometimes thought acceptable, and sometimes perceived as anathema, and the person coming from elsewhere may be welcomed or repelled simply for being from elsewhere.

Bemerkung							
Many refer to our current times as the age of the Anthropocene, marked by the devastating effects of anthropogenic (human-made) destruction, of which polluted oceans, deforestation, mass extinction and climate-induced displacement are only a few examples. At the same time, such an approach that focuses on humans as a global, geological force runs the danger of homogenizing 'the human' in ways that obscures how both harms and responsibilities are unequally distributed: after all, not all humans in all parts of the world are implicated in and affected by climate collapse and environmental destruction in the same ways. How do we live in this contemporary moment differently and across differences, sharing certain experiences such as 'nostalgia' or 'climate angst,' while yet facing different risks and harms in our lives, and having different forms of agency available? Environmental catastrophes, furthermore, affect not only humans but also the more-than-human world, thus begging the question of multispecies forms of justice. It is through literature that we will interrogate how the effects of environmental crises are unevenly distributed along lines of race, gender, class, and citizenship, as well as across different species, and how these play out against the background of North American environmental and immigration politics as well as ongoing (settler) colonialism. We will trace how literary works engage in different ways with questions of justice: how do they portray interconnected forms of environmental injustice, both social and ecological injustice? How do they imagine forms of justice? Students should be willing to engage with different text forms and genres, including prose, (video-) poetry and theory. They should be ready to approach the texts with curiosity and open-mindedness, to challenge and rethink their own assumptions, and to engage with each other in a shared process of learning. Format : This class alternates between in-person (synchronous/live) classes on campus and online (asynchronous/at home) sessions on a biweekly basis . It therefore requires both in-class attendance and online participation. In order to allow for more in-depth discussions in class, and to hone in on their critical reading and writing skills, students are expected to work independently with materials provided for them in the asynchronous sessions.

Kommentar

Throughout the Victorian Era, the ghost story has often served as a means to address unconformable topics such as death, sexuality and fears of degeneration more directly than could have been done in more realistic fiction. Women writers used the genre to criticise their gender role restrictions in the patriarchal society which saw marriage and motherhood as the only proper occupations for women. Similarly, authors used the form to write about men and the gender expectations they were supposed to act on. By leaving a loophole for a rational explanation of the seemingly supernatural events, these stories hinted at the possibility that ghosts are nothing but a hallucination and are therefore not located in external forces but within the mind of the ghost-seer. Thus, the genre provided a platform for the subtle criticism of societal issues.

In this seminar, we will explore the characteristics of the ghost story and examine the ways in which the genre was used to erode, challenge, mock and/or blur contemporary ideas about gender, sexuality, and the supposed superiority of the white Englishman. For this purpose, we will read a wide selection of stories – among them stories by famous authors such as Charles Dickens, Rudyard Kipling and Arthur Conan Doyle. In the course of the semester, we will also discuss literary theories about ghost stories and encounter Sigmund Freud and his psychological concept of the uncanny.

Kommentar

In his book *Phonographies: Grooves in Sonic Afro-Modernity*, Alexander Weheliye argues for the importance of sound reproduction technologies in the creation of a "sonic Afro-Modernity". Weheliye critiques Modernity's focus on ocularcentrism and proposes instead to attune to an aural mode of being and becoming, a "sound thinking", which he sees emerging in black and Afro-diasporic literary and musical engagement with sound technologies. By way of Weheliye's notion of phonography (literally: sound-writing), we want to think about issues of writing, reproduction and performance (as well as their entanglements). Phonographic re/production blurs the dichotomy of object and subject, as Fred Moten, Theodor W. Adorno and other theorists have argued. In this seminar, we want to read Weheliye's book to investigate theories of phonography which can function as a different entry point into studying cultural and aesthetic productions (texts, sounds, music, etc.). We will primarily read Weheliye's monograph. with the addition of some shorter texts to provide responses and context. In class, students will have to prepare short response papers and there will be plenty of space to listen to examples that illustrate or probe the theory.

The ancient world had very high rates of human mobility and moments when 'the foreigner in our midst' was not a problem, while other periods are characterised by what on the surface appears to be xenophobia, yet even then movement continued both voluntary or forced, whether for trade, piracy, wars, festivals, escape or love interests. One of the problems of the ancient world was how to keep one's own people in one place. The course will incorporate human mobility trends and the attitudes to them across a wide chronological and geographic spectrum. As its core case study it will use the ancient world centred on the Mediterranean, especially Italy before Empire, but it anticipates students from multiple disciplinary backgrounds who will be able to apply the concepts and problems discussed to their own time period and disciplinary interest. It will include approaches to the subject of mobility and the changing concepts of borders, place, citizenship and the foreigner. These issues will inform our understanding of how communities construct and use place and space, in relation to memory, identity and power. This course brings together a dynamic group of students to discuss urgent issues of our time through intriguing ancient sources and current select readings (not all those listed in each session). It will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will have the possibility to join a Global Studies trip to Friedland Museum (near Göttingen). Encounters between hosts and strangers are at the core of some of our oldest surviving narratives through time. The actions and decisions taken over the threshold, whether in welcome or repulsion, serve to position society within a moral framework, and simultaneously re/define the framework itself. Asylum appeals, by their nature, constitute the 'host' through pointing to the existence of bodies positioned external to it. Yet, the negotiations for refuge also expose the ambiguity of who the host is. In this course we will seek to understand how value is drawn from persons, whose condition is reduced to being bodies out of place. That is whose physical position means removal from – a place of rights, protection and belonging – whether through expulsion or by being relegated to spaces of constrained mobility – asylum seekers, refugees, exiles, captives and those without effective citizenship. We will draw on ancient and modern and imaginary liminal settings to investigate the unique role of people in such states for articulating intra-community relations and the space between civil rights and human rights. Individuals and groups in such positions of liminality – whose state is considered one of exception and characterised by precarity, unsettledness and threat of violence have a significant role in articulating the parameters of the non-exceptional – the so called 'norm'. Here the perplexities of sovereignty are revealed, not only for the host, but for those – citizen-strangers, the stateless or people with non-effective citizenship – whose existence lies seemingly beyond the possibilities of sovereign action, and yet there is the power to invoke it. The course brings together a dynamic group of students and international experts to discuss urgent issues of our time. Aside from discussions about select readings (not all those listed in each session), it will include 'meet the author' sessions (and possibly a joint effort to coordinate hosting the guest), a trip to Friedland Museum Transit Camp, and will engage with the International Lecture series Migration and Displacement – Histories, Stories and Myths, which will be coordinated with ROUTES: Migration, Mobility, Displacement, the UK Based Network at the University of Exeter. In addition students will get extra credit by attending as audience members an International Global LAB student virtual conference at Princeton. Kommentar

As we witness multiple ways people are on the move, by desire or by force, crisscrossing oceans, mountains, skies and at times borders, we note that the unceasing movement may be accompanied by a surge of assertions about fixity of people, importance of sustaining traditions and the naturalness of ethnic or national boundaries. These are often projected back into history as the norm. As movement increases, voices proclaim desirability of the opposite – and with it emerge stories of pause and homelands – real and imagined. It could be that we are faced with just such a moment now in the 21st century. An emphasis on locality and homeland, while living in an age of intense mobility, is not an uncommon paradox. It does not disprove the mobility thesis, and may even confirm it – we cannot get away from the immense impact of movement in our evidence. Yet, it is a response that gives prominence to stasis rather than motion as the basis for understanding transformations of human relations with each other and the natural world around us. This view has affected how we interpret societal forms, the creation of institutions, formation of boundaries and modes of cultural interaction and belonging. If, however, we accept the fact of a mobile rather than a stable society, our understanding of the dynamics of change alters. Migration becomes a constitutive presence and not a challenge to an otherwise naturally static state. The historical paradigms we will explore in this lecture series with international guests and ROUTES network (Exeter, UK), touch on different moments in time, providing a long-term perspective on contemporary concerns by locating them in rival contexts. In these dynamic situations human mobility is sometimes thought acceptable, and sometimes perceived as anathema, and the person coming from elsewhere may be welcomed or repelled simply for being from elsewhere.

In 1984, Gayle Rubin wrote that "it is precisely at times such as these, when we live with the possibility of unthinkable destruction, that people are likely to become dangerously crazy about sexuality." Rubin shows that while for some sexuality may seem an unimportant topic, "a frivolous diversion from the more critical problems of poverty, war, disease, racism, famine, or nuclear annihilation," the abjection of sexual behaviors, discourses, and subjectivities deemed abnormal and unhealthy is more than collateral for political projects. It is, rather often, its fundamental logic and ultimate objective. Kommentar

This course introduces students to the field of Australian Studies through a focus on different Australian places. It asks how these places are often simultaneously understood and imagined as Indigenous Country, as the site of colonisation and settler homemaking, or as locations of a modern multicultural nation. The process of narration plays an important role in such understandings and imaginings of places and we will focus on how and why such narratives (in the broadest sense) are constructed and what forms they might take. Starting out from an engagement with the Aboriginal Australian concept of 'Country', we will focus on iconic Australian locations such as the outback, the beach, the city, or the border and ask how they are narrated across a range of cultural productions including literature, film and the visual arts.

The course is part of the EDUC alliance and has been developed collaboratively between Masaryk University, Czech Republic, and the University of Potsdam, Germany. This course will provide a space for critical interrogation and discussion of food cultures and the politics that are associated with them. The foundational tenet of this seminar is that food is of particular political relevance despite attempts to portray it as 'just culture'.

Prospective participants should also start looking critically at the food cultures and material consumption with which they engage every day as class, race and gender structure food practices. Part of this critical self-reflection will be the creation of a food protocol over two weeks in order to help students identify aspects of their food ways that they find particularly interesting.

In 1984, Gayle Rubin wrote that "it is precisely at times such as these, when we live with the possibility of unthinkable destruction, that people are likely to become dangerously crazy about sexuality." Rubin shows that while for some sexuality may seem an unimportant topic, "a frivolous diversion from the more critical problems of poverty, war, disease, racism, famine, or nuclear annihilation," the abjection of sexual behaviors, discourses, and subjectivities deemed abnormal and unhealthy is more than collateral for political projects. It is, rather often, its fundamental logic and ultimate objective. This course will introduce students to critical conversations in the field of digital humanities, seen through the perspective of postcolonial Indian poetry in English. In this course students will read foundational texts (essays and articles) that discuss questions related to knowledge-production, postcolonial literature, and the formation of archives in the age of digitisation and digital humanities. Alongside this, the class will also read a selection of Indian poems/zine issues in each class. We will use material from three zines: *Vrishchik*, *Quest*, and *City Lights Journal*. Basic data visualisation techniques will be explored in the course of this class. However, no prior knowledge of data visualisation or programming is required to enrol in this class.

Kommentar

This course introduces students to the field of Australian Studies through a focus on different Australian places. It asks how these places are often simultaneously understood and imagined as Indigenous Country, as the site of colonisation and settler homemaking, or as locations of a modern multicultural nation. The process of narration plays an important role in such understandings and imaginings of places and we will focus on how and why such narratives (in the broadest sense) are constructed and what forms they might take. Starting out from an engagement with the Aboriginal Australian concept of 'Country', we will focus on iconic Australian locations such as the outback, the beach, the city, or the border and ask how they are narrated across a range of cultural productions including literature, film and the visual arts.

The course is part of the EDUC alliance and has been developed collaboratively between Masaryk University, Czech Republic, and the University of Potsdam, Germany. To allow for close collaboration between lecturers and students from both universities, the course will be partially co-taught. Students must generally be able to attend all classes listed in the schedule.

Next to the regular class time, this course is also taught in 5 joint online sessions with our Czech partners on 21 April, 28 April, 5 May, 12 May and 19 May from 10:15-11:45 am.

Bemerkung

Many refer to our current times as the age of the Anthropocene, marked by the devastating effects of anthropogenic (human-made) destruction, of which polluted oceans, deforestation, mass extinction and climate-induced displacement are only a few examples. At the same time, such an approach that focuses on humans as a global, geological force runs the danger of homogenizing 'the human' in ways that obscures how both harms and responsibilities are unequally distributed: after all, not all humans in all parts of the world are implicated in and affected by climate collapse and environmental destruction in the same ways. How do we live in this contemporary moment differently and across differences, sharing certain experiences such as 'nostalgia' or 'climate angst,' while yet facing different risks and harms in our lives, and having different forms of agency available? Environmental catastrophes, furthermore, affect not only humans but also the more-than-human world, thus begging the question of multispecies forms of justice. It is through literature that we will interrogate how the effects of environmental crises are unevenly distributed along lines of race, gender, class, and citizenship, as well as across different species, and how these play out against the background of North American environmental and immigration politics as well as ongoing (settler) colonialism. We will trace how literary works engage in different ways with questions of justice: how do they portray interconnected forms of environmental injustice, both social and ecological injustice? How do they imagine forms of justice?

Students should be willing to engage with different text forms and genres, including prose, (video-) poetry and theory. They should be ready to approach the texts with curiosity and open-mindedness, to challenge and rethink their own assumptions, and to engage with each other in a shared process of learning.

Format : This class alternates between in-person (synchronous/live) classes on campus and online (asynchronous/at home) sessions on a biweekly basis . It therefore requires both in-class attendance and online participation. In order to allow for more in-depth discussions in class, and to hone in on their critical reading and writing skills, students are expected to work independently with materials provided for them in the asynchronous sessions.

Kommentar

In his book *Phonographies: Grooves in Sonic Afro-Modernity*, Alexander Weheliye argues for the importance of sound reproduction technologies in the creation of a "sonic Afro-Modernity". Weheliye critiques Modernity's focus on ocularcentrism and proposes instead to attune to an aural mode of being and becoming, a "sound thinking", which he sees emerging in black and Afro-diasporic literary and musical engagement with sound technologies. By way of Weheliye's notion of phonography (literally: sound-writing), we want to think about issues of writing, reproduction and performance (as well as their entanglements). Phonographic re/production blurs the dichotomy of object and subject, as Fred Moten, Theodor W. Adorno and other theorists have argued. In this seminar, we want to read Weheliye's book to investigate theories of phonography which can function as a different entry point into studying cultural and aesthetic productions (texts, sounds, music, etc.). We will primarily read Weheliye's monograph, with the addition of some shorter texts to provide responses and context. In class, students will have to prepare short response papers and there will be plenty of space to listen to examples that illustrate or probe the theory.

This class will be taught by Malte Kobel.

Prüfungsnebenleistung	Prüfungsnebenleistungen sind für den Abschluss eines Moduls relevante Leistungen, die – soweit sie vorgesehen sind – in der Modulbeschreibung der fachspezifischen Ordnung beschrieben sind. Prüfungsnebenleistungen sind immer unbenotet und werden lediglich mit "bestanden" bzw. "nicht bestanden" bewertet. Die Modulbeschreibung regelt, ob die Prüfungsnebenleistung eine Teilnahmevoraussetzung für eine Modulprüfung oder eine Abschlussvoraussetzung für ein ganzes Modul ist. Als Teilnahmevoraussetzung für eine Modulprüfung muss die Prüfungsnebenleistung erfolgreich vor der Anmeldung bzw. Teilnahme an der Modulprüfung erbracht worden sein. Auch für Erbringung einer Prüfungsnebenleistungen wird eine Anmeldung vorausgesetzt. Diese fällt immer mit der Belegung der Lehrveranstaltung zusammen, da Prüfungsnebenleistung im Rahmen einer Lehrveranstaltungen absolviert werden. Sieht also Ihre fachspezifische Ordnung Prüfungsnebenleistungen bei Lehrveranstaltungen vor, sind diese Lehrveranstaltungen zwingend zu belegen, um die Prüfungsnebenleistung absolvieren zu können.
Studienleistung	Als Studienleistung werden Leistungen bezeichnet, die weder Prüfungsleistungen noch Prüfungsnebenleistungen sind.
