Obwohl Prozessdenken in der Verwaltung oft vernachlässigt wird, ist es essenziell für die effiziente Gestaltung von Arbeitsabläufen. Der Kurs fokussiert auf die systematische Erfassung von Prozessen, um Effizienzpotenziale zu identifizieren und Schwachstellen aufzudecken. Unsere Projektpartnerin, die Investitionsbank des Landes Brandenburg (ILB), hat bereits begonnen, ihre internen Prozesse zu analysieren und zu verbessern. Im Rahmen des Kurses werden die Studierenden an diesem realen Fall arbeiten, um praktische Erfahrungen zu sammeln. Sie entwickeln eigenständig Lösungskonzepte, die sie anschließend den Vertreter der ILB präsentieren. Kommentar

This seminar aims to provide the students with an understanding of how modern societies handle public money in general, as well as the institutional arrangements in Germany in particular. It deals with questions such as, what is the role of the budget, does it make any difference if the ministry of finance or the legislature are powerful or not, and what can different countries learn from each other?

The seminar is roughly divided into four sections. First, we will cover the main theoretical concepts and provide a framework for understanding fiscal governance and public money. The second section will delve into how all of this is applied in practice. The third area will look at the case of Germany in detail, and the final section will then broaden the perspective to compare countries in the OECD and beyond.

A syllabus covering all the usual details, including the formal course requirements, will be shared and presented during the introductory session.

Kommentar

The course aims to provide a structured knowledge of the resurgence of radical populism in Europe. It looks at the reasons for this "populist explosion", as the American journalist John Judis (2016) put it, challengers' entrepreneurial strategies and established parties' strategic responses, and how this affects political spaces. Anchored in the spatial theory of party competition, this course combines the demand and supply sides of politics to provide students with a comprehensive framework for understanding and analysing the contemporary game of politics. Although the course is primarily based on theoretical knowledge, it will also cover the dynamics of party competition, methods for estimating party positions, and the dimensionality of political spaces. Theoretical concepts and methodological approaches will be discussed interactively with students and applied to Germany and other European countries.

The main goal of this seminar is to introduce students to the possibilities and pitfalls of automated content analysis with R. Beginning with a brief overview of text-as-data methods, this seminar delves into specific text-mining techniques, including algorithms for supervised and unsupervised ideological scaling. The course will include theoretical sessions introducing and discussing the conceptual frameworks described in the reading material, as well as hands-on exercises applying the main preprocessing and text-mining methods.

Applied examples include, among many others, discrimination on Blablacar (Tjaden et al. 2018), political advertising on Wikipedia (Göbel & Munzert 2017) or measuring the impact of journalistic articles' publication on social media activity on Twitter (King et al. 2017).</p> <p>This course aims at enabling students with the R programming skills necessary to gather online data for their research by themselves and to transform it into a format suitable for analysis. Different types of online data sources (static web pages, dynamic web pages, APIs) will be covered that need different approaches in R. To scrape multiple pages, automatization techniques such as for-loops will be covered. It will also be discussed how large language models such as ChatGPT can assist you in writing your syntax. Research papers applying the methods will be provided as readings and can be discussed if there is sufficient time.</p> <p>Students are required to bring their own Laptop with a recent version RStudio installed. It is advantageous to already have some basic knowledge of the R programming language before visiting the course. If this is not the case and you would still like to participate, I recommend using one of the many online sources beforehand (e.g. https://jaspertjaden.github.io/course-intro2r/).</p> <p>At the end of the course, there will be a graded assignment in which students gather web data by themselves and report the key insights in a seminar paper. Depending on course size and preferences, this may also happen in small groups.</p>

Kommentar

The course aims to provide a structured knowledge of the resurgence of radical populism in Europe. It looks at the reasons for this "populist explosion", as the American journalist John Judis (2016) put it, challengers' entrepreneurial strategies and established parties' strategic responses, and how this affects political spaces. Anchored in the spatial theory of party competition, this course combines the demand and supply sides of politics to provide students with a comprehensive framework for understanding and analysing the contemporary game of politics. Although the course is primarily based on theoretical knowledge, it will also cover the dynamics of party competition, methods for estimating party positions, and the dimensionality of political spaces. Theoretical concepts and methodological approaches will be discussed interactively with students and applied to Germany and other European countries.

Kommentar

Multilateral organizations face increasing challenges. Member states leave or threaten to leave international organizations, governments cut funding or block appointments of supranational representatives, and non-state actors organize protests and campaigns. In this seminar, we will deal with recent research on legitimacy and legitimacy crises in international organizations in three blocks. First, we examine the foundations and principles of legitimacy beyond the nation state and get an idea of the empirical state of research on different international organizations. Why do some organizations enjoy greater legitimacy than others? Which factors explain variation in the level of legitimacy? In a second part, we will study the causes of the increasing importance of the question of legitimacy and focus on research on the politicization of regional and global governance structures. In the third part of this seminar we will focus on research on protest, opposition and resistance against international organizations: who are the opponents of these institutions and what are their motives? Since when, why and with what consequences have both states and non-state actors opposed certain forms of cooperation in multilateral institutions?

Kommentar

This seminar aims to provide the students with an understanding of how modern societies handle public money in general, as well as the institutional arrangements in Germany in particular. It deals with questions such as, what is the role of the budget, does it make any difference if the ministry of finance or the legislature are powerful or not, and what can different countries learn from each other?

The seminar is roughly divided into four sections. First, we will cover the main theoretical concepts and provide a framework for understanding fiscal governance and public money. The second section will delve into how all of this is applied in practice. The third area will look at the case of Germany in detail, and the final section will then broaden the perspective to compare countries in the OECD and beyond.

A syllabus covering all the usual details, including the formal course requirements, will be shared and presented during the introductory session.

Kommentar

Course Description

In recent years, a multitude of state and non-state actors have emerged within the so-called "Global South" to take up an ever more prominent role in international politics. This begs the question: How do we study the Global South, and which tools can we (or should we) draw on to do so?

The social sciences, including international relations, have a long pedigree of Global Northern researchers studying the Global South. Historically, this study served primarily to confirm imperial theories, racist hierarchies and developmental clichés. But there have always been voices critiquing (neo-)colonial traces in contemporary knowledge production and centring on ways how to study political dynamics in the Global South with appropriate ethics and methodological rigour.

This seminar seeks to combine qualitative methods, the study of the "Global South" broadly defined, and critical/post-colonial theory. First, the seminar introduces students to some core methods of qualitative data collection and data analysis and gives space for students to practise them and apply them to topics of interest. Second, the seminar applies these methods across a variety of issue areas related to the Global South, from statehood to democracy, empire and sexuality. Finally, the seminar shows the genesis of knowledge production on the Global South along colonial and racist lines and aims to rethink whether and, if yes, how we (as students in Global Northern institutions) should study the Global South. The seminar offers space for exchange and collaboration among students: through discussions, presentations and other creative forms of engagement. For the final grading delivery (Prüfungsleistung), students will produce a podcast episode in groups which can be published online.

Intended Learning Outcomes

This course introduces students to the study of security politics and presents a variety of methodological and thematic angles on what security is and how to conceptualise it. At the end of the course, students will be able (1) to understand, adequately select and apply the main qualitative methods of international relations and political science more broadly; (2) to critically assess existing empirical, theoretical and methodological approaches to (the study of) the Global South drawing on critical theory; (3) to design independent research on issues related to the Global South, methodology and its critiques; and (4) to use the format of Podcasts to present and discuss (their own) academic findings.

Voraussetzung

Class Format

This course follows a weekly seminar format. I will briefly present and initiate the day's topic, which is followed by student presentations, a group debate, and group work. The course ultimately builds on student participation, so students are expected to complete the required readings and to actively participate in discussions. All students are required to prepare a very short written summary statement for each of the mandatory readings.

Students need no prior knowledge of the study of qualitative methods or the Global South but should have solid knowledge of core theories of political science/international relations as well as social scientific methodology. In-class discussions will be conducted in English, although German contributions are equally welcome. Summary statements may be submitted in either English or German.

Participation Requirements: Summary Statements

In order to pass the participation requirements of this course, **students have to submit a summary statement for each required reading specified in the syllabus**. These should be structured in the following way: 1) 3-5 keywords; 2) the author's main argument in your own words (50-100 words); 3) one or two questions that the reading raises for you. Students should be prepared to explain their questions during class and discuss them with their peers.

The summary statements should be uploaded via Moodle, where a dedicated section has been created for that purpose. The summary statements for all readings of a given day should be uploaded *at the latest* until midnight before the respective course day. Two exemptions from handing in summary statements are allowed. No summary statement is needed for the reading of the first class on October 14.

Students are encouraged to submit visual formats summarising one reading per double class instead of a summary statement for this specific reading. This may be memes, TikTok videos or other ideas students have. Look [here](#) for examples. There are various platforms to create memes, for example, [here](#). Creative submissions are optional (but fun!).

Grading Requirements

This course follows a portfolio system in its grading requirements. This means that students' grades are not dependent on just one final delivery but consist of a variety of factors listed here.

Group Memo during Class

Throughout the course, students will be asked to co-author a memo for one required reading during the course of the seminar in groups of 2 or 3 (depending on class size). Memo groups and readings will be assigned in the first session. Generally, memos should be around 1000 words long (10% margin plus/minus). They should summarise the reading, present the reading's puzzle, research question and findings, and offer a set of thoughtful and diverse questions to drive discussion. Students should be prepared to answer questions about the reading.

The group memo replaces the summary statement for the authoring students for this class. It should be submitted via Moodle.

Group memos will not be marked on their content but failure to submit leads to a drop in your grade. They serve to spark students' thought processes and to structure the classes.

Podcast Episode (Sketch and Final Episode)

Students will produce a podcast episode for the final delivery of the class in groups of 2 or 3 people (depending on class size). The podcast episode should address a major question in the study of the "Global South" and related issue areas by applying a qualitative method of data collection and a method of data analysis. Students are expected to propose potential topics themselves, but you can ask me for leads or advice at any time.

The episode should deal with analysing or answering the research question and not with a detailed description of the subject matter or the general historical background. The question addressed must be formulated early on and then answered throughout the episode with the use of various qualitative methods. Students are expected to discuss, talk about, and present this topic accordingly.

In order to prepare participants for the production of a podcast episode, the course features two classes where we invite experienced podcasters to discuss a) how to best use academic knowledge in podcasting, and b) how to produce a podcast. In terms of technical equipment and technical problems (or necessary software), I am happy to help.

Students need to have come together in groups of 2-3 people by Class 6 (18.11.2024). These groups should submit a sketch for a podcast episode by Class 10 (16.12.2024) which details the topic, methods of choice and rough outline for the podcast episode. This sketch should be between 2 and 3 pages. Podcast sketches will not be marked on their content but failure to submit leads to a drop in your grade. They serve to give students space to develop their thinking early on and to receive feedback well ahead of time. Students will receive feedback from the lecturer for their sketches, which students should ideally implement before class 14 (Podcast Workshop) when we all read each other's episode sketches and give feedback and suggestions.

We can publish the final episodes online as a proper podcast. Each student needs to agree to this publishing process. If a group does not consent, their podcast is not published (which is absolutely fine as well!).

Kommentar

According to the Discipline-Specific Regulations for MANIA, this module „conveys knowledge about the legal factors affecting administrative work in the national and supranational contexts. Students will learn the basic structures of German administrative law, but also focus their attention on the Europeanization of administrative law“.

In this sense, this block seminar includes 11 topics dealing with the system and hierarchy of sources of administrative law, the rule of law principles for administrative procedures and decisions, forms of administrative action under public law and private law, the administrative structure and organisation in Germany and the EU and the administrative implementation of EU law, the legal status and administrative tasks of local authorities in a European comparison and the impact of EU law in different fields such as environmental law, the simplification of establishment and service provision, and the regulation of network industries. Finally, the German system of judicial proceedings before administrative courts (again including EU impact) and the state liability of the EU and of member states for violation of EU law will be examined.

The module exam comprises an oral presentation of approx. 30 min. and an associated term paper of 15-20 pages. As a supplementary exam work, a research exposé of approx. 5 pages followed by a feedback reflects the mid-term processing status.

Pre-existing legal knowledge in the field of constitutional, administrative, and EU law is not required but beneficial. In addition, participants shall take into account that adequate German language skills facilitate access to the predominant German literature.

The number of participants is limited to 11. Any necessary selection procedure will be carried out according to § 9b BAMA-O.

Finally, the German system of judicial proceedings before administrative courts (again including EU impact) and the state liability of the EU and of member states for violation of EU law will be examined.

The module exam comprises an oral presentation of approx. 30 min. and an associated term paper of 15-20 pages. As a supplementary exam work, a research exposé of approx. 5 pages followed by a feedback reflects the mid-term processing status.

Pre-existing legal knowledge in the field of constitutional, administrative, and EU law is not required but beneficial. In addition, participants shall take into account that adequate German language skills facilitate access to the predominant German literature.

Only 150 years ago, people were able to get a job in the labor market, only asking for work. For most of the people work was a question of labor demand. If a worker was needed, the pure workforce was sufficient to carry out the activity. Collected experience, personal reference letter or family references were helpful and increased the likelihood of getting a job. But, basically no formal training or conformed certificate was necessary to enter the workforce. This has changed drastically in the course of educational expansion: Today, young people must have passed different qualification levels from school level to vocational training or tertiary level and it is required to show different levels of qualification by official certificates. Hence, nowadays credentials have become the gatekeeper to getting a job. The modern 'Schooled Society' (Baker 2014) is based on the principle that credentials are necessary to enter qualified positions, wherefore a continuously increasing number of occupations require formal education.

Over the last 150 years, the educational level of the population increased in almost all countries. Never before, were this many people so highly educated, and never before, families spend so much money to get their children educated. David Baker (2014) called this development "the education revolution". Over 4 family generations only, education has become a universal feature for all children.


However, up to now social inequality in educational attainment remains in all societies. Either the access to school and to different school levels or the educational outcomes measured by grades, competencies or credentials follow country specific tracks of social inequality. But why can this be the case when the upgrading, understood as the "big picture" of the educational development in the last 150 years is just an ongoing process?


In this seminar, we explore the worldwide development of the upgrading of the population. We ask, what kind of consequences arise out of this development for families and the education of their children.

Die folgenden Begriffserklärungen zu Prüfungsleistung, Prüfungsnebenleistung und Studienleistung gelten im Bezug auf Lehrveranstaltungen für alle Ordnungen, die seit dem WiSe 2013/14 in Kraft getreten sind.

- Prüfungsleistung** Prüfungsleistungen sind benotete Leistungen innerhalb eines Moduls. Aus der Benotung der Prüfungsleistung(en) bildet sich die Modulnote, die in die Gesamtnote des Studiengangs eingeht. Handelt es sich um eine unbenotete Prüfungsleistung, so muss dieses ausdrücklich („unbenotet“) in der Modulbeschreibung der fachspezifischen Ordnung geregelt sein. - Prüfungsnebenleistung** Prüfungsnebenleistungen sind für den Abschluss eines Moduls relevante Leistungen, die – soweit sie vorgesehen sind – in der Modulbeschreibung der fachspezifischen Ordnung beschrieben sind. Prüfungsnebenleistungen sind immer unbenotet und werden lediglich mit "bestanden" bzw. "nicht bestanden" bewertet. Die Modulbeschreibung regelt, ob die Prüfungsnebenleistung eine Teilnahmevoraussetzung für eine Modulprüfung oder eine Abschlussvoraussetzung für ein ganzes Modul ist. Als Teilnahmevoraussetzung für eine Modulprüfung muss die Prüfungsnebenleistung erfolgreich vor der Anmeldung bzw. Teilnahme an der Modulprüfung erbracht worden sein. Auch für Erbringung einer Prüfungsnebenleistung wird eine Anmeldung vorausgesetzt. Diese fällt immer mit der Belegung der Lehrveranstaltung zusammen, da Prüfungsnebenleistung im Rahmen einer Lehrveranstaltungen absolviert werden. Sieht also Ihre fachspezifische Ordnung Prüfungsnebenleistungen bei Lehrveranstaltungen vor, sind diese Lehrveranstaltungen zwingend zu belegen, um die Prüfungsnebenleistung absolvieren zu können.
- Studienleistung** Als Studienleistung werden Leistungen bezeichnet, die weder Prüfungsleistungen noch Prüfungsnebenleistungen sind.
